Then I divided the Company into one Billion shares. So now, in the spirit of this Company, I can offer you some of my shares for about CHF 45.- each.

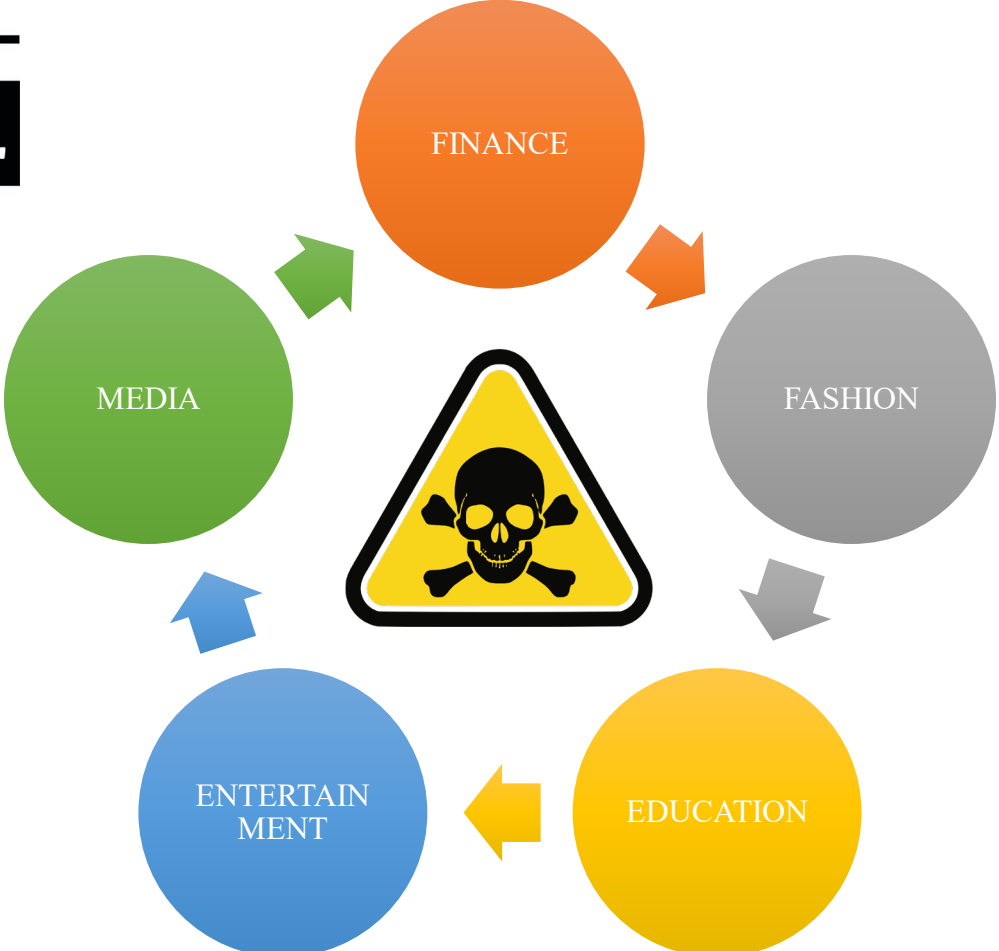
And why should you buy some of my shares, right ? You will find your own answers. But I will say:
